APTA CREDENTIALED CLINICAL INSTRUCTOR PROGRAM Level II

Course Description:

From 2007 to 2017, the APTA offered the Advanced Credentialed Clinical Instructor Program (ACCIP), which was available to credentialed physical therapists to advance both clinical teaching and best practice when providing student clinical education. The ACCIP has now been replaced with the Credentialed Clinical Instructor Program Level II (CCIP Level II), which is open to a wider audience. The CCIP Level II both applies and goes beyond the concepts of the structured and effective learning environment from CCIP Level I to allow participants to further develop their clinical teaching skills and construct a clinical curriculum. The program's unique philosophy and design will enable clinical educators to achieve the best outcomes for student learning.

Objectives

At the conclusion of the Credentialed Clinical Instructor Program Level 2, the participant will be able to:

- 1. Discuss the benefits and key components of a clinical curriculum.
- 2. Advance clinical teaching concepts learned in the Credentialed Clinical Instructor Program, Level I (CCIP I) as applied to the novice-mastery clinical practice continuum.
- 3. Integrate professionalism into a clinical curriculum that promotes the guiding principles to achieve the Vision for the Physical Therapy Profession (2013) and the core values.
- 4. Diagnose and foster a student's clinical reasoning.
- 5. Outline a clinical curriculum to meet key learning experiences critical to patient management in their practice.
- 6. Integrate interprofessional education and collaborative practice into a clinical curriculum.
- 7. Integrate advocacy into a clinical curriculum.

Intended Audience

The CCIP Level II is designed for <u>physical therapists and physical therapist assistants</u> who have supervised or overseen the supervision of at least one student in clinical practice or have been actively involved in student learning and education since receiving the APTA CCIP Level I credential. Clinicians from <u>other health care professions</u> who have completed CCIP Level 1 and meet the above student supervision criteria are also welcomed to participate but would not be awarded the Level II credential.

Pre-Course Assignments

Once registration is received, you will be sent an electronic list of pre-course assignments *to be completed prior to your attendance*. There is no additional cost for pre-course assignments, and some provide additional CEUs. **Note: Due to the time required to complete the pre-course assignments, participants are encouraged to register as soon as possible.**

Credit

Successful completion by PTs and PTAs can earn 1.7 CEUs and the APTA CCIP Level II credential. Other health care professionals are eligible to receive 1.3 CEUs. They are not awarded the Level II CI Credential.

Note: Participants must attend each session in its entirety and complete the Assessment Centers to be eligible for APTA CCIP Level II Credential.

Presenters:

Lynn Frank, PT, DPT, NCS, is a DCE in the DPT Program at St. Ambrose University and a member of the Iowa Clinical Education Collaborative Lynn served as the SCCE at Genesis Medical Center in Davenport, Iowa, for six years before her appointment at the University in 2000. Alecia has been practicing physical therapy since 1991 and athletic training since 1994.
